Quality of life at the end of our lives and the lives of those we love

Planning in advance for the medical and legal issues that come into play as we age and at the end of our lives frees us up to focus on the spiritual and family issues that we find more meaningful.

Quakers Anita Paul and Barbara Spring of NYYM's ARCH program (Aging Resources Consultation and Help) are willing to come to Ithaca to lead a workshop on Advance Directives and end of life issues, taking into consideration Quaker Testimonies that provide guidance making these decisions.

These issues are hard to figure out on our own, and here is an opportunity to talk about them and sort through them with Friends. We are in the exploratory stages, and whether or not this workshop will take place in Ithaca depends on the interest in our Meeting.

There are options on what the workshop will include:

- **2 ½ hour workshop: Legal documents**

Choosing a Healthcare Proxy—When is the Durable Power of Attorney needed?; Living Will – Caring Conversation questions, Hard Choices for Loving People; DNR (Do Not Resuscitate) orders; MOLST- Medical Orders for Life-Sustaining Treatment; Vial of Life usefulness

- **4 hour workshop: Helping the end of life be meaningful and go smoothly**

Care teams, ethical wills, hospice, funeral and burial considerations

- **6 hour workshop: Spiritual Issues**

Quaker thought on end-of-life issues; Pastoral Care during life-threatening occasions; Vigiling and Final Gifts; Consideration of Quaker values of Stewardship, Simplicity & Integrity

This workshop might take place this summer, possibly Saturday, July 11. Please let Bronwyn Mohlke (277-4183 / bjm9@cornell.edu) know of your interest in general, and also whether you would be available on that date.

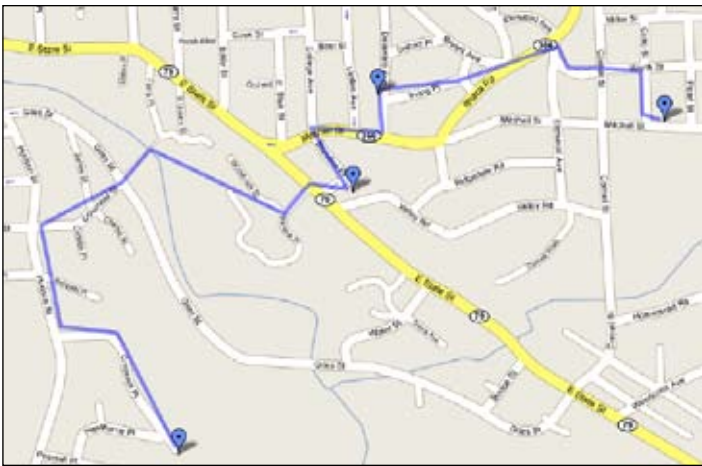

Words to Consider from Meeting for Healing

We are built to make mistakes, coded for error.

— Lewis Thomas

(For it is through our errors that we learn and grow.)

You and I are the Phoenix. We too can reproduce ourselves from the shattered pieces of a difficult time. Our lives ask us to die and to be reborn every time we confront change—change within ourselves and change in our world. When we descend all the way down to the bottom of a loss, and dwell patiently with an open heart, in the darkness and pain, we can bring back up with us the sweetness of life and the exhilaration of inner growth. When there is nothing left to lose, we find the true self—the self that is whole, the self that is enough, the self that no longer looks to others for definition, or completion,

or anything but companionship on the journey. It's all in the way we approach the changing nature of life; it's all in the courage to say yes to whatever comes our way; it's in the way we listen for the messages in the flames and dig for the treasure in the ashes.

Each one of us, regardless of our situation, is looking for the same treasure in the ashes. We are in search of our most authentic, vital, generous, and wise self. What stands between that self and us is what burns in the fire. Our illusions, our rigidity, our fear, our blame, our lack of faith, and our sense of separation: All of these—in varying strengths and combinations—are what must die in order for a more true self to arise. To begin, we must name what needs to burn within us.

Minutes of the May 2009 Meeting for Worship with Attention to Business of the Ithaca Monthly Meeting

200905.1 Gathering. The Ithaca Monthly Meeting (IMM) of the Religious Society of Friends met on May 3, 2009, in the Cafe, Anabel Taylor Hall, Cornell University, for Meeting for Worship with Attention to Business. At 12:35 PM, 16 F/friends settled into worship. Clerk read from the NYM Advices and Queries for May (available in the IMM newsletter). The Minutes were read from the April Meeting for Worship with Attention to Business. Clerk reviewed the agenda for today's meeting. @

200905.2 Nominating Committee. Melody Johnson brought the recommendation that Melissa Travis Dunham serve the remainder of Virginia Cranch's term on the Burt House Committee; APPROVED. More members are needed for this committee, as well as for Program and M&O. @

200905.3 Naming Committee. Steve Mohlke brought the committee's proposal that Sue Ruff and Alexa Yesukevich serve on the Nominating Committee. APPROVED. @

200905.4 Ministry and Oversight Committee [M&O]. Steve Mohlke brought several items from M&O.

- a) The Clearness Committee for Emily Williams and Alexa Yesukevich (consisting of Rini Clarkberg, Marion DaGrossa, Nancy Gabriel, and Steve Mohlke) has found the couple clear to be married under the care of IMM, and M&O recommends that the marriage go forward. APPROVED.
- b) The concern for the clock in the Edwards Room has been discussed by the committee with input from several f/ Friends. M&O brought a recommendation that there continue to be a clock in the Edwards Room during Meeting for Worship, but that ways be found to make it quieter. APPROVED.
- c) Arianna White has expressed her desire to participate in the Out of the Nest program, and M&O has approved CALM's recommendation of Bronwyn Mohlke as her mentor. @

200905.5 Finance Committee [FC]. Dick Crepeau reported that the committee has researched ways to coordinate the various designated funds under IMM's care, and has created an internal working document to keep track of these diverse accounts. In line with these efforts, the FC brought several Minutes for the monthly meeting's discussion and approval:

- a) "The Ramallah School Fund will be laid down." This Minute was APPROVED. Concerned f/Friends will look into other appropriate ways to continue IMM's support for the Ramallah, Palestine Meeting and School.
- b) "Unused monies currently held in the Meetinghouse development Fund will be transferred back into the New Building Fund." APPROVED
- c) "The Burt House Building Fund will be discontinued and the money in it transferred into the New Building Fund." APPROVED

Other information was given on changes FC is making in how IMM finances are managed. The Cash Flow Fund will be increased to smooth out periods when commitments exceed donations. FC has also considered which committees ought to be involved in the approvals process for certain specific funds. @

200905.6 Treasurer. Steve Mohlke expressed appreciation the Finance Committee's initiatives and decisions, which facilitate the Treasurer's work. He reviewed the monthly report for April and it was received by the Meeting. @

200905.7 Clerk reported that circumstances supported a one-month extension for the Refugee Working Group's six-month report, which is expected in June. @

At 2:10 p.m., 14 F/friends gathered in silent worship before adjourning. We will meet again for Worship with Attention to Business on June 14, 2009.
