Paper Clips and the Holocaust

n January 28, at a gathering of Kol Haverim in Ithaca in remembrance of the Holocaust, I had one of the most moving experiences of my life. I saw a documentary of a small, poor town in Tennessee (Whitwell), where the middle school principal wondered how to broaden the understanding of students about cultures and peoples other than the good white, Southern Christian people of her town. With some other people, it was decided to learn about Jews and the Holocaust. Someone (one of the students, as I recall) came up with the idea of using paper clips, one for each of the six million Jews who perished in the Holocaust. The students wrote to many people, in America and in other countries, to Jews and to others, telling them about their paper clip project. At first, the number of paper clips received was small, and they thought that the most they could get would be only a little more than one million, if that, But then, it took off, Tom Brokaw learned of the project and mentioned it on his evening news program, and many others began to recognize the simple sincerity of the students and their families in this small Tennessee village. By the time the project ended they had amassed more than 27 million clips, from all over the world.

But vastly more important than the numbers of paper clips were the contacts they made—wonderfully moving contacts with Jews who responded to the earnest efforts of the students and the townsfolk. When the people decided that they would build some sort of memorial of the Holocaust, and chose to make that small

memorial something significant, such as a railroad boxcar like the ones that carried so many people to Auschwitz and the other Nazi death camps, there were Jews whom they had met who told them that they would get them such a car. And indeed they did, traveling to Poland to find one of the old cattle cars into which more than a hundred Jews had been crowded, some suffocating from the awful conditions, on the final journey. The people of the town took this car, and built a deeply moving memorial, attended by many people. Among other things, it contains 11,000,000 paper clips, in remembrance of the six million Jews and the five million other people—Gypsies, gay people, and any other people murdered in the death camp because they were judged unfit by the Nazis.

I have seen such a thing, along with many other items of remembrance, in the Permanent Exhibit at the United States Holocaust Memorial Museum in Washington, DC. It, too, was deeply moving to me. But I could not have imagined that a small and poor town in southeastern Tennessee could, in total unity, produce so strong a light to the world about the need for human beings to understand each other, and to build friendships and caring among us all. They have proved that caring people of good will can accomplish magnificent things.

The documentary film about this moving story is beautifully done, wholly with the real people who lived it, not with actors. Its title is, simply, "Paper Clips." It has already won many awards.

Thor Rhodin Remembered

Dear Friends:

Thor Rhodin passed away peacefully in his sleep on Friday morning, February 17, at a local hospice where he had been for a few days since he was discharged from Cayuga Medical Center. He was 85 years of age.

Thor was a very active member of our Meeting from the time of his arrival in Ithaca in 1958 until the last year or so when his health began to deteriorate. He was Clerk of our Meeting in 1976 and Co-clerk with Elspeth in 1977 and 1978. He was ac-

tive in the Meeting's First Day School both in the 1960s and later in the 1980s. He also served at various times as Recording Clerk, on the Program Committee, Ministry and Oversight, Trustees, Peace and Social Action, and the Burtt House Committee. Over the years Thor served on a number of Clearness Committees for Membership and for Marriage. He also served as our representative to Regional Meeting and to New York Yearly Meeting.

During the Vietnam War, Thor was an active draft counsellor. He worked evenings and weekends in a storefront rented downtown by our Meeting for this purpose, and in subsequent years when the office was moved to Anabel Tayor Hall.

Plans for a Memorial Service have not yet been made. Ministry and Oversight will work with the family on this.

200602.1 The Ithaca Monthly Meeting (IMM) of the Religious Society of Friends met on February 12, 2006, at the Cul de Snack, Anabel Taylor Hall, Cornell University, for a Called Meeting of the Corporation, and for Meeting for Worship with Attention to Business. At 12:40 p.m., F/friends settled into worship.

200602.2 The Called Meeting of the Corporation of Ithaca Monthly Meeting of the Religious Society of Friends was called to order.

200602.3 Change of the By-Laws:

- I, Melanie-Claire Mallison, affirm and state I am of legal age and sound mind and that I am mindful of my obligation to tell the truth. I further state as follows:
- 1. I am the Recording Clerk of the Ithaca Monthly Meeting Of The Religious Society Of Friends (the "Meeting"). I have the duty of recording the transaction of business sessions of meetings of theMeeting. I make this statement in accordance with the requirements set forth in Section 201-a of the Religious Corporation Law Of The State Of New York ("RCL").
- 2. As directed by a minute of the Meeting, I caused a notice in the form attached as Exhibit A (which notice is incorporated to this Statement by this reference) to be published in the Meeting's regular Newsletter for the month of January, 2006.
- 3. With this Statement, I certify the Meeting held a Called Meeting For Worship With Attention To Business on February 12, 2006 (the "Meeting For Business"). At that Meeting for Business, 25 members and attenders considered the topic of a proposed change to the Meeting's By-laws: In the event of dissolution, all of the remaining assets and property of the Meeting shall, after necessary expenses thereof, be distributed to the New York Yearly Meeting Of The Religious Society Of Friends or another religious corporation related to the Religious Society of Friends so long as the entity receiving the assets and property is not a benevolent organization, as that term is defined in the Tax Law, such distribution to be subject to the approval of a Justice of the Supreme Court of the State of New York as provided in the Religious Corporation Law.

4. In the course of that Meeting for Business, it was the sense of the meeting (such terms used in accordance with Section 9 of the By-laws), that the change referenced in Section 3 of this Statement be made to the By-laws as a new section 20 and that the same change also be made to the Meeting's Certificate of Incorporation.

200602.4 The minutes were read to this point and approved. This concluded the business of the corporation. @

200602.5 Twenty-four Friends settled into worship in preparation for Meeting for Worship with Attention to Business. Our clerk asked Esther Darlington to share with us today. Esther read excerpts from the following, Memoirs of Charles J. Darlington (her dad), Volume 2, and Advices of the [Religious] Society of Friends from 1656, and noted her own thoughts on worship. The minutes of the January Annual Meeting and the January Called Meeting were read. @

200602.6 Treasurer's Report: Steve Mohlke summarized the report for January. Friends received the report. @

200602.7 Design Committee: Dick Crepeau reported that our architect is aware of the request from January's Called Meeting. Ernie will answer to that request as soon as he can. @

200602.8 Peace Witness Committee: Mac Larsen reported on the upcoming dinner with Newton Garver, president of the Bolivian Quaker Education Fund. The committee encourages everyone to attend and learn of this important work which Ithaca Monthly Meeting supports thru its Gifts. @

200602.9 Request from Bonnie Tyler: Eh Christ and Mu Mu and their new baby will be moving soon into their own apartment. Bonnie requests — if they have to pay a security deposit, will Ithaca Monthly Meeting assist them with that expense? Friends approve paying the deposit if we could first work with Bonnie to inspect the apartment and then request a report from the landlord if and when the family moves out. @

200602.10 Burtt House Committee: Tom Brown reported for the committee on the various recent changes. The caretaker's position is presently vacant, and the committee is considering applications. Till the position is filled, friends are asked to contact committee members to use the facility. Even though there are now babies in the house, there are no new policies regarding Burtt House use, though the committee may have to consider some requests in this light. @
